

Marine Insurance Seminar Articles - Insights to Help You Navigate the Industry

Evolving Challenges and Solutions in Marine Fire Suppression

Over the past five years, the marine fire suppression industry has faced significant challenges and changes. Traditionally, clean fire suppression systems like FM-200 (HFC227ea) and NOVEC 1230 (FK5112) have been the primary solutions, especially for recreational pleasure craft. However, the AIM Act of 2020 imposed restrictions on products contributing to global warming, significantly limiting the availability and use of HFC227ea.

Additionally, PFAS (Perfluoroalkyl and Polyfluoroalkyl Substances) have emerged as a major environmental concern, with many states proposing bans. It's important to note that PFAS encompasses a wide range of products. While some PFAS are persistent in the environment and labeled as "forever chemicals." others break down rapidly and are safe for various applications, including fire suppression. FK5112, for instance, has an atmospheric lifetime of just five days and is non-toxic within its design concentration. The 3M Corporation's decision to cease production of all PFAS products, including FK5112, has led to misconceptions about FK5112 being a forever chemical, which it is not. It continues to be readily available and remains a viable and cost-effective solution for marine fire suppression.

With the phasing out of HFC227ea, aerosol fire suppression systems have emerged as a viable option for marine vessels. These systems offer an effective solution that is efficient, compact, and lightweight. The AT-series by SEA-FIRE® is one such example. Unlike clean fire suppression systems, aerosol systems do leave a residue that requires cleanup. However, in scenarios where lack of cleanup is not a priority, aerosol systems provide a practical, cost-effective solution, especially in situations where space and weight are critical concerns.

The marine sector is also facing increasing challenges with the rise of lithium-ion batteries in devices (i.e., tools, recreation toys, etc.) and as alternatives to fossil fuels for supplemental energy and propulsion. Lithium-ion battery fires are highly destructive, extremely dangerous, and difficult to suppress due to their high energy density and the phenomenon known as thermal runaway. Thermal runaway is an uncontrolled positive feedback loop where the battery releases stored energy as heat, leading to expansion, leakage of flammable electrolytes and gases, catastrophic explosions, and fires that spread rapidly to adjacent cells. Conventional fire suppressant agents are not designed to mitigate thermal runaway and often fail when used on lithiumion battery fires. Even if the flames are smothered, the underlying thermal runaway can cause reignition, sometimes immediately or deceptively long after initial suppression.

To effectively address a lithium-ion battery fire, an agent must smother the flames and halt the thermal runaway within the battery cells. The marine industry is now heavily focusing on lithium-ion battery fire protection, with guidelines and recommendations calling for modifications to vessels' fire control plans to incorporate suitable fire protection measures. One suitable agent that has been designed, tested, and shown to be effective on lithium-ion battery fires is the thermal runaway mitigator used in LiCELL® fire extinguishers. It targets both flames and thermal runaway. This highly beneficiated mineral-based suppressant is all-natural, environmentally safe, produces no toxic byproducts when used on a fire, and can be readily incorporated into fire control plans.

In summary, the marine fire suppression industry has been rapidly evolving to meet new regulatory and technological challenges. The continued transition from fossil fuels to alternative energy sources like lithium-ion batteries, along with accompanying new regulations, can be expected to hasten further changes in this ever-evolving industry.
