Marine Insurance Seminar Articles - Insights to Help You Navigate the Industry

A SUMMARY JUDGEMENT FOR THE DEFENCE

by Raul Chacon, Jonathan Dunleavy, Katherin Kaplan - Wilson Elser Moskowitz Edelman & Dicker LLP In a case of first impression, the Southern District of Florida addressed whether a website can be liable for a vessel owner's acts or omissions as a livery, statutorily or under general maritime law. On February 9, 2024, the Southern District of Florida granted summary judgment in favor of a large peerto-peer boat rental company represented by Raul Chacon, Jonathan Dunleavy, and Katherine Kaplan, in a wrongful death case, finding that the web-based peer-to-peer boat rental platform cannot be liable as a livery under the Florida livery statute § 327.54 Fla. Stat. (2021) and amended (2023). Given the growth of the peer-to-peer vessel rental market, such a decision has the potential to have strong national

implications as to the liability of web-based vessel sharing platforms.

The case arose from an incident that occurred in March of 2022, when the Decedent was thrown from a boat operating in the

Atlantic Ocean just off the Boca Raton inlet. The boat encountered heavy seas, which caused the rented boat to roll, ejecting her from the boat, resulting in injuries which lead to her untimely death. The Decedent had chartered the boat utilizing an online peer-to-peer boat rental platform. The platform allowed the owner of the vessel ("Owner") to post his boat for rental by potential users who requested rental through the platform. However, the platform did not dictate the terms of any rental, nor was it involved in the exchange of any boat for hire.

Because the subject boat was chartered through the peer-to-peer platform, the Decedent sought to hold the website liable for the breach of duties owed to the renter and/or charterer of a boat under the Florida Livery Statue as well as those owed under general maritime law. Despite many states having similar livery statutes, and the wide usage of peer-to-peer boat rental platforms, prior to the Court's ruling, there was no clarity as to the liability of an online platform for a maritime incident. Livery statutes govern the rental, lease, or charter of vessels, setting safety requirements to protect boat renters. Like many states with such statutes, the livery statute applicable in Florida at the time of the incident failed to define a livery. While Florida's legislature recognized this deficiency and has since made efforts to clarify who qualifies as a livery through the Boating Safety Act of 2023, the application in the context of peer-to-peer rental has not yet been addressed.

Prior to the Court's ruling, it was unclear whether the duties to advise as to safe operation, and those to ensure vessel safety for renters under the livery statute § 327.54 Fla. Stat. could be read to extend to a peer-to-peer website. Because the underlying basis

from the third-party posting of a vessel on the website, it was determined the company was immune from liability as a livery where it merely offered a forum for information provided by

third-party vessel owners to connect to renters. The Court determined that the web-based platform was merely a conduit in the vessel rental process and was subject to the protections afforded under Section 230 of the Communications Decency Act. 47 U.S.C. § 230 (2018). Section 230 of the Communications Decency Act prohibits the treatment of providers or users of an interactive computer service as "publisher or speaker of any information provided by another information content provider." Id. § 230(c)(1). Under Section 230, immunity arises when the platform can show that: "(1) [it] 'is a provider . . . of an interactive computer service, (2) the claim is based on information provided by another information content provider, and (3) the claim would treat the [party] as the publisher or speaker of that information." Doe on Behalf of Doe v. Grindr, LLC, No. 5:23-CV-193-JA-PRL, 2023 WL 7053471 (M.D. Fla. Oct. 26, 2023). Prior to this, Section 230 had not been applied in the context of a marine charter, forcing the Court to consider the website's

role as simply a classified ad no different from Airbnb (peer-to-peer home sharing)¹, Turo (peer-to-peer car rental)², Grindr (location-based online dating targeted towards gay men)³, Offerup (customer-to-customer marketplace)⁴, or Craigslist (classified

ad website)⁵. Ultimately, the Court agreed that the Website was entitled to the federal immunity, where the platform had no right of disposition of a vessel and found that it cannot not be held accountable for any applicable safety standards relating to the rental of the boat itself.

In addition to the federal immunity afforded under Section 230, the Court found that the peer-to-peer platform was not a livery under the 2021 Florida Livery Statute. § 327.54 Fla. Stat. In particular, it found that because the 2021 statute provided no definition of a livery, it was found that to be a considered a livery,

the party must be in a position to "knowingly lease, hire, or rent a vessel to any person". § 327.54(1) (c), Fla. Stat. (2021) (emphasis added). The website lacked authority to enter into such agreements as it was neither owner nor owner pro hac vice with any possession or control of the vessel. Because the website simply provided a platform for a boat owner/ livery to advertise a boat rental, negotiate a rate, rent that vessel, and earn a rental fee, absent a small subscription charge, the website was not offering that vessel.

This holding by the Southern district establishes a basis for handling similar suits nationally involving the rental of a vessel through a peer-to-peer platform. Given the increased popularity of these platforms, it is likely more and more of these suits will be brought.
